vCJD Implementation

As of May 2022 the FDA has released revised deferral criteria for Creutzfeldt Jakob Disease (aka Mad Cow Disease). Donors who were previously deferred due to risk of exposure to CJD / Mad Cow Disease have been reinstated as potential donors. What's changing?

Over 20 years ago, the FDA implemented regulations to protect transfusion recipients against the possible risk of variant Creutzfeldt-Jacob Disease (vCJD, also known as Mad Cow Disease). These regulations prevented many people who lived in or traveled to the United Kingdom, France, or Ireland from donating blood in the US. After years of study and no documented risk of vCJD through blood transfusions, the FDA removed this donor restriction.

DONOR ELIGIBILITY UPDATE: Under new guidance from U.S. Food and Drug Administration, [Blood Center Name] to reinstate donors previously deferred from blood donation for time spent in Europe

[Blood Center Name] will reinstate more than [insert number] potential donors who were previously deferred from blood donation under donor eligibility guidance that was recently updated by the U.S. Food and Drug Administration. Following new guidance issued by the FDA in May, [Blood Center Name] has removed indefinite deferrals for [insert number] potential donors who were previously deferred from blood donation due to travel or residence in the United Kingdom, France, or Ireland. The deferral was related to a theoretical risk of transmitting Cruetzfeldt-Jakob Disease (also known as Mad Cow Disease) to blood transfusion recipients. FDA has determined this is no longer a concern for donors who have previously lived in the United Kingdom and other European countries.

The new guidance from FDA removes the deferral recommendations associated with geographic risk of Mad Cow Disease for time spent in the United Kingdom (1980 – 1996); time spent in France and Ireland (1980 – 2001); and receipt of a blood transfusion in the U.K., France or Ireland (1980 – present). The opportunity to expand the blood center's donor base comes during a challenging time for our region's blood supply. In recent weeks, the blood supply has been as low as just a two- to three-day supply for type O-negative and O-positive red blood cells. 


